**IMPORTANT REMINDERS:**

- The last day to register to vote for this election is **Monday, October 22, 2018**.
- Voter registration cards are available at locations throughout Tulare County. To obtain a mail-in registration card, please call (559) 624-7300 or 1-800-345-VOTE, a free hotline. If you prefer, you can also register online at: [www.sos.ca.gov](http://www.sos.ca.gov).
- **Tuesday, October 30, 2018** is the *last day* the Registrar of Voters office may receive Vote by Mail requests through the mail. Otherwise, after **October 30, 2018**, voters may come to the Registrar of Voters office located at Government Plaza, 5951 S. Mooney Blvd., Visalia, to request a Vote by Mail ballot in person.
- Tulare County residents that will be sworn in as a United States Citizen by a Federal Judge after **Tuesday, October 30, 2018**, but no later than the close of polls on Election Day, may register and vote at the Tulare County Registrar of Voters Office. You will be required to show your Naturalization Certificate at the time of registration.
- The Registrar of Voters office will be open at 7:00 a.m. on **Tuesday, November 6, 2018** for any voter who would like to come in and vote.

**NOTICE OF CENTRAL COUNT  
ACCUMULATION  
AND COMMENCEMENT OF VOTE BY MAIL  
BALLOT PROCESSING**

As per Elections Code 12109, notice is hereby given that at the General Election to be held on November 6, 2018, all voted ballots will be counted on either a Sequoia Insight or a Sequoia Edge (Touch Screen) voting unit at each polling location, and the results will be accumulated at the Tulare County Registrar of Voters Office after the polls close on Election Day. All valid Vote by Mail and Provisional Ballots will be counted at a central location on a Sequoia 400-C central count optical scan tabulation machine and not at a polling location. That central location will be at the Tulare County Registrar of Voters Office located at: 5951 South Mooney Boulevard, Visalia, California.

The polls will be open from 7:00 a.m. until 8:00 p.m. on Election Day.

As per Elections Code 15104, the Registrar of Voters also hereby notifies all interested organizations that the verifying of signatures on Vote by Mail voter ballots cast for the Primary Election will commence on October 9, 2018, in the County Registrar of Voters Office, 5951 South Mooney Boulevard, Visalia, California. On October 23, 2018, or at any time thereafter, the opening, processing and central count accumulation of Vote by Mail ballots will commence. This process will continue until all election results are tabulated and the election is certified.

The processing of Vote by Mail ballot return envelopes, and the processing and counting of Vote by Mail ballots, shall be open to the public, both prior to and after the election.

Any member of the County Grand Jury, and one member each of the Republican County Central Committee, the Democratic County Central Committee and of any other party with a candidate on the ballot, and any other interested organization, shall be permitted to observe and challenge the manner in which the Vote by Mail voter ballots are processed, from the opening through the counting and disposition of the ballots.

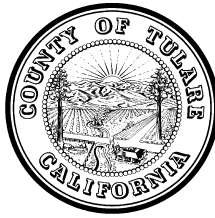
