The Registrar of Voters will consider any comments received from the public and adjust Consolidated Polling Places and Vote By Mail Ballot Drop Box locations to the extent deemed appropriate before finalizing the locations

Based on Governor Newsom's Executive Order and New Legislation for the November Presidential Election requirements are as follows:

In-Person Voting Locations:

- One (1) Polling Place per 10,000 Registered Voters (19 required for Tulare County).
- Polling locations will be open for four (4) days of voting beginning Saturday, October 31, 2020 through Election Day, November 3, 2020.
- Voters can vote at any of the Consolidated Polling Places.

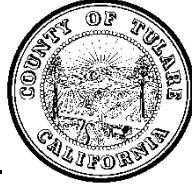
Vote By Mail:

- Every Registered Voter will receive a ballot in the mail.
- One (1) Ballot Drop Box per 15,000 Registered Voters (12 required for Tulare County).
- Election Officials are required to use the Secretary of State's Vote By Mail Ballot Tracking System (BallotTrax).

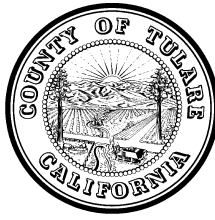
- Cada votante registrado recibirá una boleta por correo.

Extensions to the Nomination Period allow any candidate, other than the incumbent, to file for office. This list does not include districts that are primarily located in other counties.
