NOTICE OF A SPECIAL PARCEL TAX ELECTION AND NOTICE OF DATE FIXED FOR SUBMITTING ARGUMENTS FOR THE EXETER PUBLIC CEMETERY DISTRICT

NOTICE IS HEREBY GIVEN to the qualified electors of the Exeter Public Cemetery District located in the County of Tulare, in the State of California, that in accordance with the provisions of the Elections Code, Government Code, and the Health and Safety Code of the State of California, an election will be held on Tuesday, the 8<sup>th</sup> day of November, 2022, for the purpose of submitting to the qualified electors of the District the measure summarized as follows:

## EXETER PUBLIC CEMETERY PARCEL TAX MEASURE

To provide local funding to improve landscaping, maintenance and operations of the Exeter District Cemetery, Deep Creek Cemetery, and Hamilton Cemetery, improve accessibility and safety, replace worn-out equipment, upgrade facilities, drill a new water well, and improve services for local families, shall Exeter Public Cemetery District levy a special parcel tax each year in the amount of \$35.00 per parcel (increased each year by 2.5% to account for inflation) on each parcel of taxable real property within the District, beginning as of July 1, 2023?

YES

The proposition shall require approval of a two thirds (2/3) vote of the electorate voting on the tax.

Arguments for or against this measure may be submitted to the Tulare County Elections Division, 5951 South Mooney Boulevard., Visalia CA 93277, not later than August 22, 2022, which has been determined by the elections official to be a reasonable date based upon the time necessary to prepare and print arguments. No argument shall exceed 300 words in length.

Pursuant to Section 9162 of the Elections Code, one argument for and one argument against this

measure will be selected for printing and distribution to the voters with the sample ballot.

The elections official will also provide opportunity for rebuttal arguments to be filed no later than September 1, 2022 in accordance with Section 9167 of the Elections Code.

By execution of this formal Notice of Election, The Tulare County Registrar of Voters orders consolidation of the election with such other elections as may be held on the same day in the same territory or in the territory that is in part the same.

The Tulare County Registrar of Voters, by this Notice of Election, has called the election pursuant to a Resolution and Order of the Board of Trustees of the Exeter Public Cemetery District adopted on July 27, 2022.

The polls will be open Election Day between 7:00 A.M. and 8:00 P.M.
