2. Public Comments

- 3. Discuss Presidential General Election:
  - a. Poll Site Preparations.

Poll Site Preparations include equipment, supplies, Personal Protection Equipment and sneeze guards. Poll workers will be measuring out the 6 feet distances for social distancing. Pens will stay with each individual voter throughout the process. Suzette Machado, Elections Program Coordinator explained the poll sites and the process that the poll workers had to go through in order to get ready for voters. We will be advertising to Vote on buses with routes in Visalia and Dinuba.

b. Poll Worker Training.

Provisional and CVR Clerks will be trained on laptops, trainings will start on October 5, 2020. Informational guides will go out today, September 24, 2020. Training for Poll Workers starts September 25, 2020.

- 4. Review Poll Worker Accessibility Kits:
  - Porterville Veterans Memorial.
    No issues with Accessibility or Accessibility aides in supplies. The only issue is to monitor the voting area to provide assistance to Voters if necessary.
  - b. Lindsay Memorial. Doors require too much force to open, so the site will be given door stops to prop the Poll Site entrance and the voting area doors.
  - c. Tule River Tribal Office.

Accessibility issues: Existing Van Accessible Parking space does not have an access aisle; Door requires too much force to open; Door hardware requires too much force to open. Accessibility Aides in supplies: 2 cones; and doors stops. We have supplied accessibility guides to the poll workers to create an accessible aisle to the right of the Van Accessible Parking space. Place the cones at the back of the parking space, where the trunk of the vehicle typically goes to prevent cars from parking there. Prop the Poll Site entrance doors and the voting area doors.
